

PRIVACY INFORMATION ON VIDEO SURVEILLANCE

We attach great importance to your privacy and your personal data. We therefore process your data exclusively on the basis of the applicable statutory regulations, in particular the Austrian Data Protection Act - **DPA**, the EU General Data Protection Regulation (**GDPR**) as well as the Austrian Telecommunications Act (**TCA**).

This privacy policy informs you how we process your personal data in the context of video surveillance and what your corresponding rights are. This privacy information is supplemented by corresponding information signs which draw your attention to video surveillance before you enter the monitored area.

1. CONTROLLER

2. PROCESSING OF PERSONAL DATA, PURPOSE AND LEGAL BASIS

In the context of video surveillance, we may process your personal data when you are in the monitored area:

- Image data of the data subject (appearance, behaviour);
- Location of the image recording (location, camera location);
- Time of image recording (date, time, start/end of image recording).

As far as persons recorded within the scope of video surveillance are identified in case of need, we process:

- Image data of the data subject (appearance, behaviour);
- Location of the image recording (location, location of the camera);
- Time of image recording (date, time, start/end of image recording).
- Identity of the data subject, as far as the evaluator can see from the recording;
- Role of the data subject (e.g. perpetrator, victim, witness), as far as recognisable from the recording.

Purpose of the processing:

Video surveillance for the purpose of property protection/object protection against damage, vandalism, burglary and theft as well as other damaging behaviour, responsibility (in particular the fulfilment of safety obligations), as well as for the purpose of prevention, containment and clarification of criminally relevant behaviour (as far as the responsibility of the controller is concerned), including the preservation of evidence, with exclusive evaluation in the case of need defined by the purpose designation.

Legal basis

The processing is based on our legitimate interests pursuant to Art. 6(1)(f) GDPR in conjunction with §§ 12, 13 DPA (property protection/protection of objects and responsibility).

3. DO WE SHARE YOUR DATA?

Provided this is necessary and permitted to fulfill the above-mentioned purposes we may transmit personal data to the competent authorities or courts (for the preservation of evidence in criminal cases), security authorities (for security police purposes), courts (for the preservation of evidence in civil law cases), insurance companies (exclusively for the handling of insurance claims), legal representatives, employees, witnesses and/or victims (within the scope of asserting claims).

Our data processors (e.g. IT-provider) may have access to your personal data (e.g. in case of maintenance). These contract processors are contractually obliged to comply with all data protection regulations.

A transfer to third countries is not planned. There is no automated decision making.

4. HOW LONG DO WE STORE YOUR DATA?

Recorded data is automatically deleted 72 hours after recording, unless an incident requires certain data to be retained until final (possibly judicial) resolution.

5. YOUR RIGHTS

Under the GDPR, you have the following rights:

- Right to **access** the personal data concerning you that is being processed by us (Art. 15 GDPR);
- Right to **rectification** of inaccurate data (Art. 16 GDPR);
- Right to **erasure** (Art. 17 GDPR), where appropriate;
- Right to **restriction of processing** of your data (Art. 18 GDPR), where appropriate;

- Right to **object** to the data processing at any time on grounds relating to your particular situation (Art. 21 GDPR);
- Right to lodge a complaint with the supervisory authority.
